MANOR BOROUGH COUNCIL MONTHLY BUSINESS MEETING – April 15, 2020

The Manor Borough Council held its monthly business meeting on Wednesday, April 15, 2020 at 7:00 P.M., by way of an online Zoom audio and visual meeting. The Manor Borough Building is closed to the public due to the Covid-19 Pandemic.

Minutes – A motion "to accept the minutes of the meeting held on March 18, 2020, as read" was made by Ms. Lynn, and seconded by Mr. Woy. The motion carried unanimously.

Public Comment on Agenda Items – None.

Mayor's Report (Mr. Matrisch) – The Mayor noted the Charger had a bad starter. It has since been fixed under warranty.

Solicitor's Report (Mr. Campfield) – The Solicitor noted as of April 15, 2020 both Pennsylvania Houses passed legislature and sent on to the Governor for approval, a bill outlining remote municipal meetings and property tax extensions. The property tax extensions include extending deadlines, and forgiving some penalties and interest. The Borough will have to pass a Resolution to extend its tax deadlines, based on the decision made by Westmoreland County, which may require a reissuance of the tax bills.

Engineer's Report (Mr. Antonacci) – None.

Planning & Zoning Officer's Report (Mr. Krainbucher) – None.

Borough Manager's Report (Mr. Lapia) – Mr. Lapia reported the Borough Office is taking care of daily business, although it has slowed. There is a surge in lien letter requests and sewer lateral inspections due to the number of people refinancing. North Huntingdon Township lost their appeal regarding the TowerCo cell site. The Judge ruled in favor of TowerCo and the cell site can continue to be installed on Borough property.

Treasurer's Report – A motion "to approve the Treasurer's Report for the month of March 2020, as prepared" was made by Mr. Woy and seconded by Ms. Lynn. The motion carried unanimously.

Tax Collector's Report – A motion "to approve the Tax Collector's report for the month of March 2020, as prepared" was made by Ms. Lynn and seconded by Mr. Woy. The motion carried unanimously.

Ms. Lynn motioned to have a new resolution drafted to reflect the changes in order of business format. Seconded by Ms. Marchand, the motion carried unanimously.
