## INTRODUCTORY REMARKS

Mr. Gockel turned the Public Hearing over to Solicitor Ms. Chelsea Dice.

### SOLICITOR REMARKS

Ms. Dice explained the hearing is for Enacting A Volunteer Service Credit Program. Ms. Lynn is physically unable to speak and will write comments and questions which will be read by the Solicitor, or Council President, or Borough Manager. The Volunteer Service Credit Program is for Volunteer Fire Fighters. An Ordinance was drafted which was available for viewing at the Manor Borough office.

## **QUESTIONS OR COMMENTS**

Ms. Bonnie Dawson of Rowe Road, Manor, asked if the members can take one credit or both credits for earned income tax and real estate tax, how the Borough will recoup the money, and if there was a study of the amount of money involved. Ms. Dice responded the volunteers would be eligible for both credits if they qualify by the rules set forth in the accompanying Resolution; It is unknown how many volunteers will partake in the credits therefore it is unknown how much revenue will be lost. The Tax credits will take effect January 1, 2024. Mr. Lapia reported he did a casual study of the number of firefighters that live in Manor Borough, determined there were 15-20 firefighters, but not all of them may own property in the Borough, and not all of them may qualify for the credits. Additionally, their income is unknown. Mr. Lapia retrieved notes from 2019 and noted of the 15 active firefighters living in the Borough then, 10 owned real estate in the Borough. Mr. Charrie theorized the Borough would probably lose no more than \$6,000, which Mr. Gockel felt was on the high side of the estimate.

Councilwoman Lynn asked if the tax credit is being taken out of the Manor VFD annual Borough budget. Ms. Dice suggested that would be a Council decision but the VFD has requested Council do not take the annual tax credits into consideration as not all fire fighters live in Manor Borough.
